Answer: After the quarter ended Genesis Minerals Limited (GMD) announced an Offer to acquire the remaining outstanding shares in Dacian Gold Limited (DCN). Kin held 89M shares in DCN. On 17 October 2023 Kin accepted the GMD Offer and on 26 October GMD issued 15M GMD shares to Kin. GMD shares closed at \$1.455/share on 26 October 2023 giving a value of \$21.9M. GMD shares are quite liquid. Refer to the Quarterly Report for further information.
